PUBLICATIONS

In 2006 the project published one more volume in the UNIHP series by Indiana University Press: *Human Security and the UN: A Critical History*, by S. Neil MacFarlane and Yuen Foong-Khong.

An additional two volumes will be published in 2007. *Human Rights at the UN: The Political History of Universal Justice*, by Roger Normand and Sarah Zaidi went through substantial meetings, peer reviews, and revisions during 2006. *The Oxford Handbook on the United Nations* edited by Thomas G. Weiss and Sam Daws—with 864 pages and 40 chapters, written by 40 leading scholars on the United Nations—will become the authoritative reference on the organization when published in May 2007 by Oxford University Press.

The volume *Preventive Diplomacy at the United Nations: The Journey of an Idea*, by B. G. Ramcharan, after being sent for three rounds of peer review and being the topic of two peer-review discussions, is nearly ready to go into production. *The UN and Transnationals, from Code to Compact*, by Tagi Sagafi-nejad in collaboration with John Dunning, has also undergone the peer review process and will go into production later in 2007.

ORAL HISTORY

Additional funding from the Government of Finland has made it possible to complete two more interviews of key Finnish leaders: Martii Ahtisaari in July 2006 and Elisabeth Rehn in November 2006.

With the interview process completed, project staff finished indexing of the last of the transcripts, and completed a lengthy and careful copyediting process for all of the finalized, indexed transcripts in preparation for the publication of the full transcripts on CD-ROM, available in April 2007.

Work on the CD-ROM containing the complete oral history transcripts is nearly finished. The importance of this archival collection of recorded memories cannot be over-emphasized as there is precious little institutional memory at the UN and even fewer resources to capture the historical record. This CD-ROM will now make accessible, in searchable electronic format, the life stories of an extraordinary group of people from around the globe who contributed to the economic and social record of the United Nations.

Significant staff time has been devoted to working with designers in developing the layout, information architecture and content for the CD-ROM. Staff has also been creating a list of regional research institutes and

libraries to which copies of the CD-ROM will be sent for distribution. In particular, we will focus efforts on research organizations and libraries in the South in order to facilitate access by researchers in the South to these important oral histories. Copies will be sent to all major regional research institutions, including the Association of Arab Institutes and Centres for Economic and Social Development (AICARDES), the Asian Political and International Studies Association (APISA), the Latin American Social Science Council (CLACSO), the Council for the Development of Social Science Research in Africa (CODESRIA), the European Association of Development Research and Training Institutes (EADI), and the Organisation for Social Science Research in Eastern and Southern Africa (OSSREA). In addition, all UN depository libraries will receive copies.

DISSEMINATION ACTIVITIES

Project directors and authors made great efforts in 2006 to ensure that the research, ideas, and findings of this project continue to help inform debate and encourage interest in UN activities as well as facilitate further documentation of UN history. The project held numerous substantive seminar discussions organized around project research and book launches for academic and popular audiences in different world regions, wherever possible in collaboration with networks of UN researchers and other local partners.

In addition, project staff held several meetings and spent a great deal of time planning for 2007. In November 2006 the project hired Geoff Barnard, an independent consultant to help assess the dissemination work completed to date and to sketch out a new and more proactive strategy for dissemination as we move into the last phase of the project. Barnard met with UNIHP staff and conducted interviews with senior UN officials who are familiar with the project, and used these meetings to produce a report on dissemination strategies for 2007 and 2008. It is hoped that additional funding can be mobilized for targeted dissemination efforts.
